Our friend A has an inspiration for a simple super-selective cw receiver. He plans to take the output of the regular 450kc i.f. amplifier and drive a doubler stage with it. Thus signals in the i.f. at 449kc, 450kc and 451kc will appear at 898, 900 and 902kc, seperated by 2 kc instead of the original 1kc. Passing them into another receiver, they will then be eaiser to seperate, he reasoned. Why hasn't someone thought of this simple idea before?

Weather Bureau And Amateurs Join Hands In Fight

On March 2, A meeting was called by Merle G, Kachenmeister, WA8EWW, an employee of the U. S. Weather Bureau of Toledo. The purpose was to organize the Amateur Radio Tri-State Severe Weather Network.

Merle told the group of the net set-up and had a block diagram on a blackboard showing the various links. A picture will be in the next issue of the diagram.

With Merle was Mr. Fred Davis, head of the U. S. Weather Bureau. Mr. Davis spoke to the group saying the Toledo Bureau would help the amateurs as best he could with weather information and evaluate more accurately the information coming from the weather net.

He implied that a efficient net could be of great good to Toledo and the surrounding communities.

This net would link southeastern Mich. igan, northeastern Indiana and northwestern Ohio into a efficient net which would help the Weather Bureau in plotting storms and getting reports of unusal weather. All this information would be passed to points east to help give them a warning of tornadoes or damaging winds.

Merle stressed the point of checking into the various nets. He also told the group to keep their eyes pealed for tornadoes coming from the southwest.


Merle told me that the ling from Toledo to Lima was practically non-existant. I have since spoke to K8HWU and was told that a transmitter-receiver will be on both 50.168 and 50.360 mc. With this setup, the CD net will have a very good link into the weather net.

This will aid both Wood County CD and the Toledo Weather Bureau. With Delbert, W8VOZ and Virg, K8CRF on frequencies the arms are reaching out.

If we can encourage hams to the south and west, the net in our sector will be of great help. The Weather Bureau would like links to extend as far south as Lima.

Encourage amateurs to check into these nets when weather warnings are broadcast. All they have to report is unusual weather such as heavy raid, high winds, hail ect. Their cooperation may save a community a major disaster.

Next months paper will have the standard reporting procedures.

Another item that might be of interest is the Gemini frequencies. They are 5.259, 7.579, 10.613, 15.016, and 15.969 MC. These are used by Gemini control. Give a listen next launch.

73-73's

There has been some recent discussion about whether it is more correct to say "73" at the close of a phone QSO, rather the perhaps more common form "73s." Those who consider the number along as right argue from code analogy and from tradition, accepting these as sufficient grounds for their opinion. Those who use the plural form generally do so as unconsciously and as correctly as they use any other word of our American language until they are brought up short by old timers and purists who insist that the old form is the right one.

Because most people regard grammar as a list of rules which have the sanctity of mysterious authority and which are beyond discussion, users of the form "73s" do not realize upon what good ground they stand. Language changes. In the course of time words change meaning and pronunciation in spite of zealous schoolmistresses who attempt to prescribe what features standard dialect ought to have. For example, there are grammarians who insist that "ain't" is not to be used in the American language, and there are etymologists who tell us that "fuzz" may be properly applied only to federal officers. Ten minutes on most street corners will demonstrate that both are used otherwise and understood, contrary to the rules.

We can hazard the guess that code "73" became pluralized in phone use through analogy with words like "greetings" or because "73" sounds as if it should be plural; the essential thing to remember is that language is essentially arbitarary and susceptible to change and that therefore the only rule which may be applied is the one of appropriateness: to be correct the wird must convey the meaning, tone, and prestige value to the listener that the speaker desires. If it does so, it is correct. If the other fellows on the rag-chew understand and approve of the form "73s," you are justified in using it. If however, you are talking to a purist who prefers the singular, and you know it, by all means be polite and impress him with the older form; needless to say, he also will find that often he must also conform in areas that prefer the plural or else spend his time lamenting the "corrupt" state of ham jargon.

Do not be concerned about the correctness of your language while in front of the mike. Language exists only as it is used and you as hams are the ultimate authorities, within the boundaries of FCC regulations, on what constitutes "correct" amateur communication.

The doubler (or any other frequency-multiplier stage) is a ion of signals will take place. Thus the sum frequencies of the possible combinations of 449, 450 and 451 will appear along with the second harmonics. The sum frequencies work out to be seperated by only 1 kc., the original separation. Introducing the three signals into the doubler stage will produce five signals at the second harmonic: 898, 899, 900, 901, and 902.
