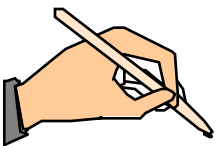

## A Note from the Editor

The new ARRL proposals for restructuring the amateur licensing regulations have indeed elicited a great deal of discussion and controversy. All you have to do is read the pages of QST to discover that fact. Over all it's the opinion of this writer that the new class structure is a good deal for all hams. In one clean move, they would expand the HF privileges of all present holders of Novice, Technician Plus, General, Advanced and Extra Class amateurs by eliminating the Novice class and its HF CW bands, and placing first three in Class C. The latter two would benefit from additional phone privileges as the Novice CW bands are carved up. The only small problem that I can foresee is the handling of a present holder of the General license (3B theory and 13 wpm code) who wishes to upgrade to Class B, which has a 12 wpm code test; do they automatically get credit for their previous proficiency or do they need to pass another code test? The best benefit of the new plan is to designate a single "entry-level" ticket, Class D, which carries all current VHF/UHF privileges. This provides a clean separation between the knowledge base for VHF/UHF and HF. It always seemed a bit silly to me for the Technician candidate to have to take on a split personality by passing the 3A test on VHF/UHF operation and element 2 on HF operation. This proposal makes sense!

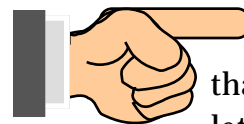

## Land Mobile Interests Backing away from 440MHz

According to QST, the Land Mobile Communications Council (LMCC), the group that galvanized amateurs into action by requesting that the FCC reallocate a sizable chunk of the 440 MHz band to their use, is backing off. You may recall that yours truly had written a letter to the AAA, which is a member organization of the LMCC, expressing disagreement with their proposal some months ago. The response from AAA could at best have been termed noncommittal.

It now seems as though that venerable organization has seen the light, and will now work within LMCC to try to reverse its position. The crucial change of heart apparently comes as a result

of the strong statements in support of amateur radio by two very influential organizations: the Association of Public Safety Officials-International, and the National Telecommunications and Information Administration. The latter group is the coordinating organization for military and other governmental spectrum users.

Even though the situation looks much more promising than it did at the beginning of the summer, the matter is by no means closed, and the AAA believes that the LMCC will maintain its request just for "appearances". There should be no sense of amateur radio winning the battle yet!

### ***What are the Sweepstakes ?***

One of the oldest HF contests still going is the ARRL Sweepstakes. The traditional November contest occurs this year at 2100 UTC on November 7th through 0300 UTC on the 9th for CW, and at 2100 UTC on November 21st through 0300 UTC on the 23rd. Although the contest runs for 30 hours total, an individual participant can only operate for 24 hours during this period. As with all contests, the WARC bands are out of bounds; only 160m, 80m, 40m, 20m, 15m and 10m.

The Sweepstakes is strictly a US/Canadian affair. The object of the contest is to make as many contacts in as many different ARRL/RAC sections. Many states constitute an individual section, but some, such as California, are divided into many sections (9 for CA). Each contact counts 2 points; the total contact points are then multiplied by the number of sections worked to get the total score.

There are 3 entry categories for single operators: QRP, low power (<150 W output), and high power (>150 W output). The exchange between stations during a contact includes the following information: contact serial number, power class (A, B or C), station call, year of first license and

section. For example, if KD8XYZ is sending his information to W1AW, the exchange would go something like: W1AW, please copy number 256 from KD8XYZ 97 Ohio. The above message says that this is contact number 256, and that KD8XYZ was first licensed in 1997 and that he is located in the Ohio section.

Many hams complain about the contesters hogging the bands during their operations, and there are certainly those who are culpable. However, it should be kept in mind that contests such as the Sweepstakes were one of the best means hams have to test propagation conditions on all bands at the same time. A Sweepstakes contestant could be working the West Coast on 15m just as it opens up in the morning, and 5 minutes later work the more proximate states of PA, MI, IN and KY on 80m. Give it a shot! You're sure to enjoy it.

The application fee for obtaining vanity call letters has been reduced, as of September 14th. The new charge is \$13, which is a welcome reduction from the previous rate.
