#### FCC Begins Stronger Enforcement Policy

(excerpted from the ARRL Letter)

In a move that is bound to be welcome to most amateurs, the Federal Communications Commission has publicized and begun to act on a stronger enforcement of the amateur radio regulations. The FCC's Riley Hollingsworth, K4ZDH, who has been placed in charge of the revamped enforcement system, has made it clear in no uncertain terms that the actions of a few "bad apples" who have been maliciously interfering with other amateurs especially on 20m and 75m will no longer be tolerated. This group also includes certain folks who think it's a kick to tie up repeaters and to interfere with their legitimate operation.

Hollingsworth has composed a list of the ten worst offenders and has sent them warning notices (what used to be called a "pink slip") demanding that they reply with the promise of compliance with the regulations, or else face the penalty round. Those hams who have had the misfortune to tune across some of the shenanigans on 14.313, for example, will roundly applaud this action.

Strong enforcement consists of two parts: dedicated observation to identify wrongdoers, and the real possibility of serious penalties being imposed by the FCC. For the past two decades, this ob-

- Vanity update: the FCC says it received 1412 vanity applications during October, down only slightly from September when the fee dropped to \$13. More than 80% of applications filed in recent months have been electronic. Over the more than two-year life of the current vanity call sign program, the FCC has received more than 36,250 applications for new call signs.
- FCC sets exam fee reimbursement maxi-The FCC has announced that the 1999 maximum Amateur Radio volunteer Examination reimbursement fee will be \$6.49, based on a 1.5% Consumer Price Index increase between September 1997 and September 1998. The 1999 ARRL/VEC test fee will be \$6.45. The 1998 ARRL/VEC test fee was \$6.35. Note: Elements 1(A) - 5wpm code- and 2 - Novice theory - are always free
