eliminate noise from the power system but has found that course too difficult. They have decided not to invest in a BPL system but are willing to rent power line use to Dacor if Dacor can find the necessary investors. The equipment for BPL tested by the city and Dacor has six power settings but only 1-3 are ok from an interference point of view. While level 4 can also work levels 5 and 6 interfere. Dual band equipment and the use of radio links where there is power line interference is great might work out. A great deal of time was invested by Loren, Dacor, and the city.

Ed Hare of ARRL labs came to town and met with Loren and George Stossel. Loren was left with both a very positive impression of Ed, and of the meeting itself where Ed and George were able to have a levelheaded dialogue with much information exchanged. With the city abandoning plans for BPL they will unfortunately (for us) be less motivated in finding RF noisy spots in their infrastructure.

an opportunity to gain operating experience under sometimes extreme conditions, both environmental and operational. Typically, power is provided by portable generators, but other non-mains sources can be used; antennas are usually strung up in trees. Extra credit is awarded for using exotic forms of power generation such as solar energy or wind power.

The activity takes the form of a contest of sorts where each station tries to contact as many other stations as possible in as many different ARRL Sections (82 in all in the US and Canada) as possible. Entries are classified according to the number of independent transmitters that are used as well as the nature of the power source. Competition is between only those stations that enter in the same class. Come out and enjoy some operating fun, or at least come and eat!


